Why We Did This Audit

Our objectives were to determine whether the OCVS program is operating effectively, efficiently, and in accordance with applicable laws and regulations and with appropriate internal controls.

This audit was included in the 2020-2021 Annual Audit Plan.

Our overall conclusion is that OCVS activities are in compliance and operating effectively and efficiently. Our audit noted one area for improvement regarding updates of data in Skyward (the district's student information system).

Results and Recommendations

We reviewed OCVS' procedures, handbook, and intranet. We extracted the total number of active full time and part time OCVS students from Skyward and analyzed data. We noted that OCVS updates student status information in Skyward infrequently and recommended updating student status on a more regular basis.

We verified a sample of students' school/class information, their pace chart, attendance report, and their assigned district devices.

We verified a sample of teachers' certifications on FLDOE and issued Out of Field letters, if any.

We reviewed previous FEFP audit reports and management responses, and reviewed contracts related to OCVS.

This report has been discussed with management and they have prepared their response which follows.

BACKGROUND:

Orange County Virtual School (OCVS) is established in accordance with Florida Statute 1002.45 *Virtual Instruction Programs* to provide varieties of virtual school opportunities to Orange County students including:

- Full time program for OCPS grades K to 12 students.
- Part time program offers supplemental courses for OCPS grades 6 to 12 students.
- Full time program offers middle and high school courses for Orange County Home Education students.
- Part time program offers supplemental courses for Orange County middle and high school students in private schools.

The district tracks attached at the various OCVS programs by school number.

- #7001 Virtual Instruction Program operated through a contract with a provider approved by the Florida Department of Education. It includes full time and part time students.
- #7004 Participants of the district's Florida Virtual School Franchise. It includes full time and part time students.
- #7006 District Virtual Course Offerings. It includes part time students.
- #7023 Virtual Instruction Program operated as a Digital Academy by the school district for students enrolled in the district. It includes part time students.

OBJECTIVES, SCOPE AND METHODOLOGY:

Objectives

This performance audit was to determine whether the Orange County Virtual School (OCVS) program is operating effectively, efficiently, and in accordance with applicable laws and regulations and with appropriate internal controls.

<u>Scope</u>

The scope of this audit covered OCVS activities from July 2019 to October 2020.

$\underline{Methodology}$

Out audit methodology included:

- Reviewing Florida Statutes 1002.455 Student Eligibility for K-12 Virtual Instruction, 1002.45 Virtual Instruction Programs and 1003.498 School District Virtual Course Offerings;
- Reviewing OCVS' procedures, handbook, and intranet;
- Reviewing *Enrollment Summary by School* as of 10/15/2020;
- Obtaining the total number of active full time and part time OCVS students from Skyward and analyzing data through audit software;
- Selecting a sample of 58 active full time OCVS students including 15 Exceptional Student Education (ESE) and 10 English Language Learner (ELL), and 29 active part time OCVS students;

This audit covered the period from July 2019 to October 2020.

We performed detailed testing of a sample of 87 student records.

- Reviewing selected students' accounts in Skyward and Archibus systems;
- Selecting a sample of 17 OCVS teachers from SAP and reviewing teachers' field area, verifying teachers' certifications on FLDOE and SAP, and verifying any issued Out of Field (OOF) letter;
- Selecting five OCVS teachers from the School Board agenda and verifying OOF letter;
- Reviewing previous Florida Education Finance Program Full-Time Equivalent (FEFP FTE) audit report dated June 2020 and management's response on FTE report findings;
- Reviewing Florida Auditor General 2014 and 2017 audit reports and findings on OCVS;
- Reviewing student attendance report and pace chart percentage; and, teachers' follow-up emails with parents/students if student were behind their expected course pace chart; and,
- Reviewing K12 Florida LLC., Florida Virtual School (FLVS)
 Franchise, Edgenuity, Edynamics Learning Inc., and
 Smartthinking Services contracts and agreements, and verifying
 9/2019 to 11/2020 quarterly invoices of K12 Florida LLC., and
 any refunds.

Our audit was conducted in accordance with the *International Standards* for the Professional Practice of Internal Auditing of the Institute of Internal Auditors and included such procedures as deemed necessary to provide reasonable assurance regarding the audit objective. Internal Auditing is an independent, objective assurance and consulting activity designed to add value and improve an organization's operations. It helps an organization accomplish its objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of risk management, control, and governance processes.

We are required to note any material deficiencies in accordance with Florida Statutes, School Board Policy and sound business practices. We also offer suggestions to improve controls or operational efficiency and effectiveness. We noted no material deficiencies in the results of this audit.

We tested compliance with out-of-field teacher assignment requirements.

We reviewed management's responses to findings from previous Auditor General audits.

Our audit was conducted in accordance with the International Standards for the Professional Practice of Internal Auditing.

We noted no material deficiencies.

RESULTS AND RECOMMENDATIONS:

Overall Conclusion:

OCVS activities are in compliance and operating effectively and efficiently. However, our audit noted a need for more timely updates of student information in Skyward as described below.

OCVS activities are in compliance and operating effectively and efficiently.

1) OCVS updates student status information in Skyward infrequently. Significant risk/ impact

Best Practice:

Maintaining current data in the student system helps staff and management in decision-making and reporting processes.

Audit Results:

While confirming the population of OCVS' active part time and full time students with OCVS staff, we noted that 114 part time students' active/inactive statuses were not current in the Skyward system. OCVS staff informed us that they update students' data prior to the Florida Auditor General's biannual FEFP audit.

OCVS practice has been to update student data only prior to the Florida Auditor General's biannual FEFP audit.

Recommendation:

OCVS students' data should be updated frequently in Skyward. It helps staff and management in decision-making and reporting processes. When we notified OCVS staff, they updated the information in the system.

We recommend updates that are more frequent and management concurs.

We wish to thank the administration and staff of OCVS for their cooperation and assistance with this audit.
